

**Joint Village Strategic Planning  
MEETING NOTES  
Tuesday, June 1, 2021  
10 AM MST  
Zoom Videoconference and Telephone**

**1. Call to Order**

Brian Cole called the meeting to order at 10:10 am MST.

**2. Self-introductions**

Meeting attendees included Mary Bradley, Claudina Burgener, Andrew Gashwazra, Linda Honahni, Dale Lucero, Roberta Sequi, Leroy Shingoitewa, Sam Shingoitewa, Robert Sumatzkuku, Cathy Wright, and Brian Cole.

**3. Approach to Hopi Tribal Council**

It was noted that we are firmly scheduled for a time certain on June 8 at 9 am before the Hopi Tribal Council. All the documentation has been submitted to the HTC Secretary and Philton Talahyewa will introduce the matter before the Council.

The precise meeting location and formatting is still in question, although four individuals from the JVSP effort have been invited to Kykotsmovi for the presentation. The group will continue to learn of the precise meeting room and format. *(Note: shortly after the meeting we learned that the HTC will be meeting over Zoom. No need to travel to Kykotsmovi.)*

Linda Honahni reminded the group that Philton Talahyewa made mention in the previous meeting of the expectation that four people will be in person for the meeting (later in the meeting it was agreed that Leroy Shingoitewa, Claudina Burgener, Robert Sumatzkuku, and Brian Cole would be the in-person *(Zoom)* participants.

Cathy Wright stated that she brought hard-copies to the Tribal Council Secretary for distribution. The Tribal Council Secretary indicated that only four hard-copies would be necessary. There was then a discussion about whether the Tribal Council would be meeting in the Council Chambers or the DATS Conference Room. Andrew Gashwazra would double check the meeting location and report back to the group. *(See above).*

Shingoitewa noted that the documentation has now been read into the record. Shingoitewa also noted that there may be some discussion about the Office of Navajo and Hopi Indian Relocation.
